Surfect: RADIOACTIVE CONTAMINATION OF AN EMPLOYEE

On August 20, 1979, an individual contaminated his trouser knees while working on a pump in the Cap-Gun 1 liquid radwaste processing system and subsequently wore the trouser home. The contamination, about 30,000 dpm, was not detected until August 21, 1979 when the individual surveyed himself at the Cap-Gun 2 facility. The individual had surveyed himself before leaving the site on August 20th; however, the licensee stated that the survey meter used was defective due to a faulty cable. On August 21st the licensee surveyed the inclicuals's wife, apartment, clothing, and car; no contamination was found. The incividual's trousers were laundered at the TMI decontamination facility. and the contamination was removed.

The licensee determined that 11 other individuals exited through the same control point using the defective survey meter. The licensee will determine if any of these personnel were contaminated. This determination will be reviewed b. the NAC inspectors on site.

Madia interest is expected because of the public sensitivity to Three Mile is and activities. The Commonwealth of Pennsylvania has been informed. A trass release is not planned by the licensee nor NRC.
