Subject: EX-WATCHMAN INFORMS TELEVISION MEDIA OF TMI PAPERS

A watchman, who no longer works at TMI, informed the local media that he had important licensee papers obtained from the TMI site. The papers amounted to be approximately 1 1/2 inch thick. The individual claimed that he found them and did not steal them.

The licensee reclaimed the papers from the individuals' residence and immediately reviewed them. Results of the review indicated that the papers were documents which could be found in a Public Document Room (PDR) and were internal memoranda of a non-confidential nature.

Review of these papers by NRC staff appears to confirm the licensee's results. No further review is planned.

The watchman's employment by "Gregg Security" (licensee vendor) was terminated in May 1979.

The licensee is responding to press inquiries. NRC does not plan to issue a press release.

The Commonwealth of Pennsylvania has been informed.
