Subject: RESTORATION OF NORMAL MAKE-UP CONTROL.

The TMI-2 plant pressure control and make-up has been on the Standby Pressure Control System since February 11, 1980. This status was the result of isolating the Make up System due to a primary water leak. Today at 3:55 p.m. the 1B Make-up Pump was started and the Make-up System was placed back into service without incident. The Make-up System has since been operating satisfactorily in parallel with the Standby Pressure Control System.

This preliminary notification is issued for information only. Media interest is not expected. No press release is planned by the licensee or the NRC/TMI staff. The Commonwealth of Pennsylvania has been notified.
