Subject: CONGRESSIONAL TOUR

Congressman Morris Udall, Chairman of the House Interior, and Insular Affairs Committee and several other congressmen, along with congressional state members, who are members of the Energy and Environmental Subcommittee, will be touring selected areas of TMI-1 and TMI-2 today. The purpose of the tour is to assess the status of both units in which licensee and NRC briefings will be conducted. The noted subcommittee in which Congress Udall is also chairman is expected to conduct hearings on a bill related to federal fundings of the TMI-2 cleanup.

Media interest has occurred because of public sensitivity to TMI related events. A press conference is scheduled for later this afternoon by the licensee. The Commonwealth of Pennsylvania has been informed. The NRC does not plan to issue a press release at this time.
