Desk, TMI-2 Organization Plan - Revision 25,  
dated July 20, 1990

We have completed our review of your proposed Revision No. 25 to the TMI-2 Organization Plan. The proposed revision consolidates the Plant Operations Section and Plant Maintenance Section into the Plant Operations and Maintenance Section. This change reflects the reduced work activity associated with Mode 3 and the lack of need for two separate organizations to perform similar functions.

Also your July 20, 1990 submittal proposed that the TMI-2 Licensing Section would no longer report to the Director, TMI-2, but be reassigned to the Corporate Licensing and Regulatory Affairs Department of the Corporate Services Division. The TMI-2 Licensing Section would continue to provide licensing support for the TMI-2 Division. You state that this change is consistent with your efforts to consolidate activities in preparation for PDMS.

The proposed change will not eliminate any vital positions or functions within the TMI-2 organizations, nor will it change the personnel qualifications for these positions. It represents an organization realignment consistent with the progress of the cleanup. We therefore, approve your proposed Organization Plan Revision No. 25. The enclosed Figures 1.1 and 1.2, Rev. 25 should be substituted for the existing GPUN Organization Plan Figures 1.1 and 1.2. This change will become effective on August 1, 1990.

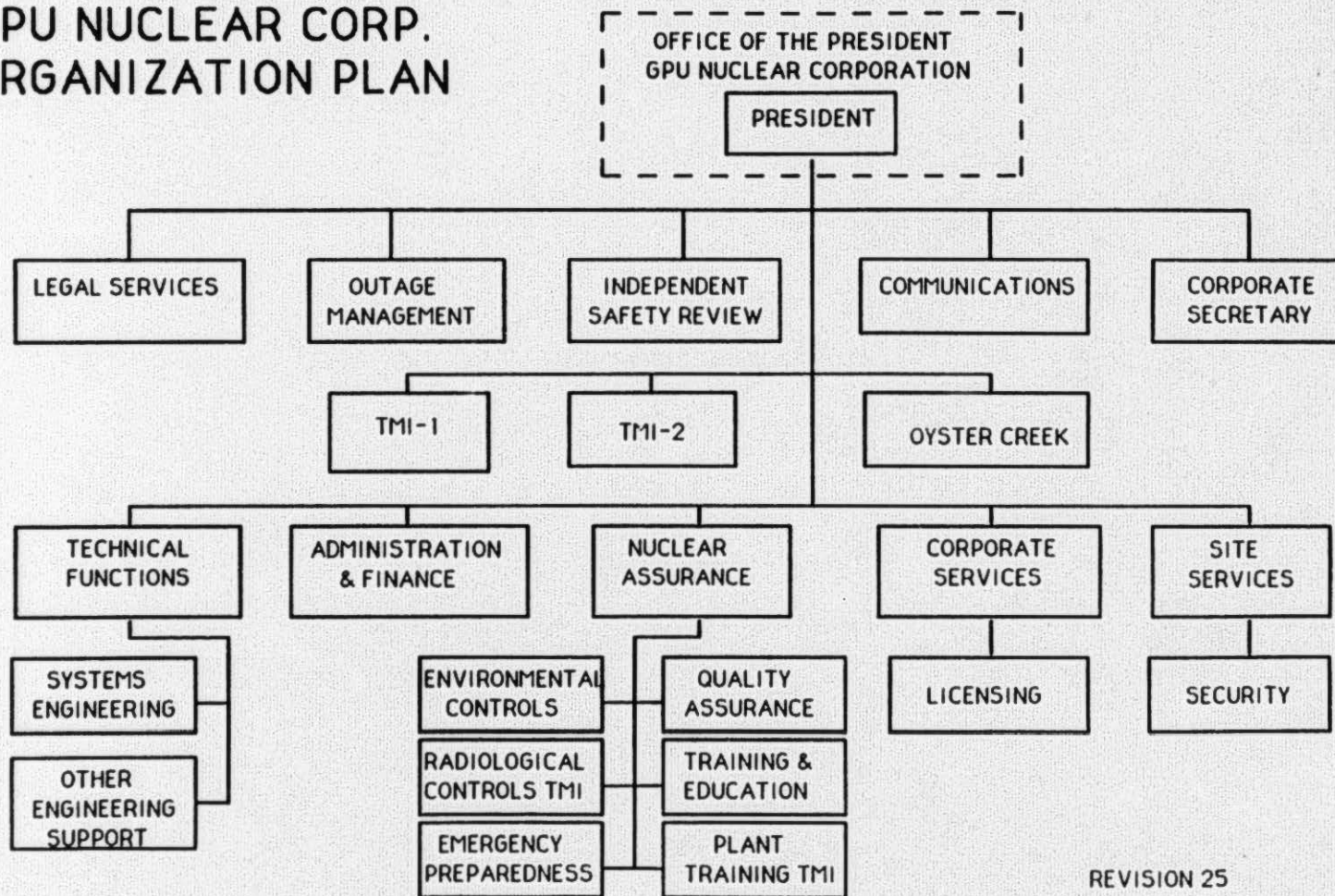

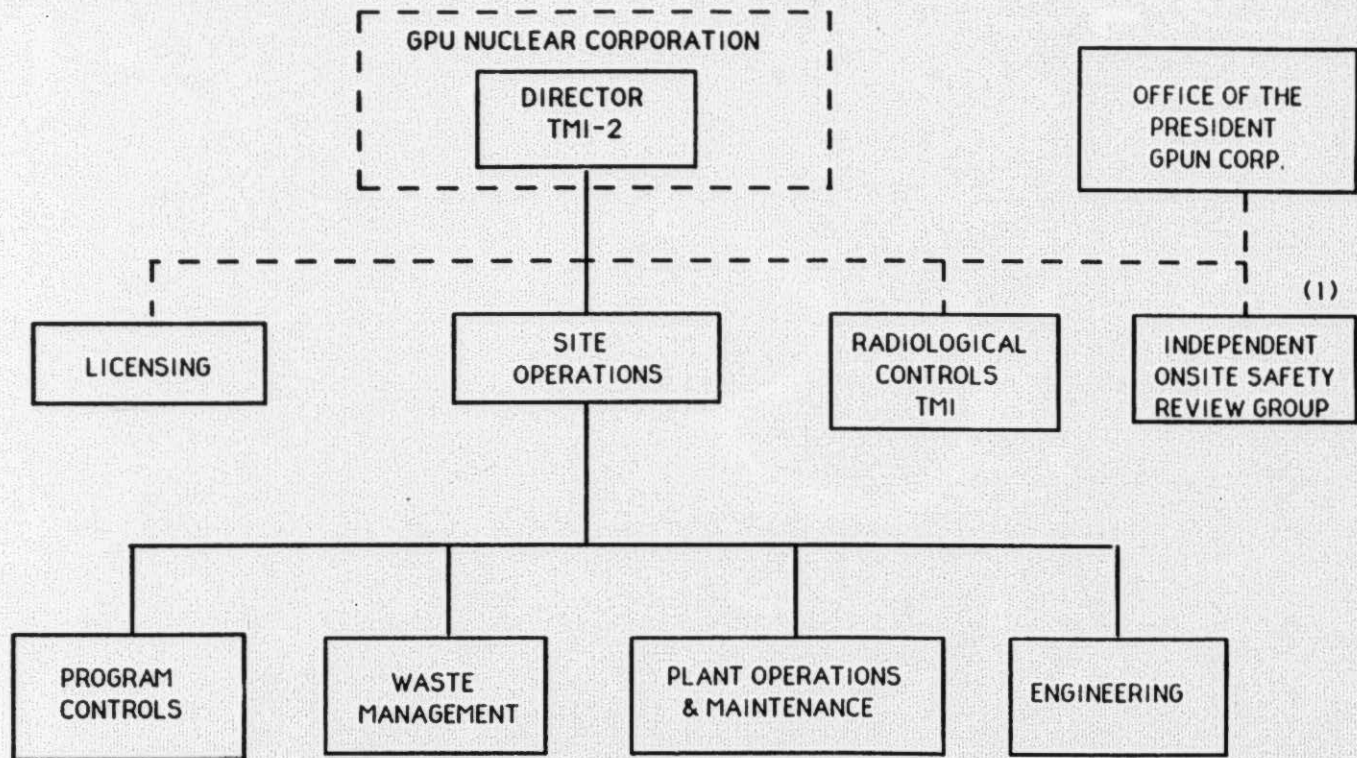
