SUBJECT: ORGANIZATION PLAN CHANGE NO. 25 (TAC NO. 76024)

Reference: Letter 4410-90-L-0004/0060P, M.B. Roche to U.S. Nuclear Regulatory Commission, Document Control Desk, TMI-2 Organization Plan-Revision 23, dated January 22, 1990.

We have completed our review of your prepared Revision No. 23 to the TMI-2 Organization Plan. This revision was submitted in conjunction with Technical Specification Change Request (TSCR) No. 65. One of the changes proposed in TSCR No. 65 is to extend the frequency of the Training and Qualification Audit to at least once per 24 months. The Organization Audit specified in the current Organization Plan is performed once every 12 months and ensures that members of the TMI-2 Organization meet the training and qualification requirements of their positions. The Organization Audit is performed in conjunction with, and is an integral part of the Training and Qualification Audit specified by the TMI-2 Appendix A Technical Specifications. To maintain consistency between the Appendix A Technical Specifications and the Organization Plan the licensee proposes extending the frequency of the Organizational Audit to at least once per 24 months.

Technical Specification Change Request 65 issued as License Amendment 39, under separate cover, discusses changing the Training and Qualification Audit requirement of the Appendix A Technical Specifications from 12 to 24 months. The staff found that because of the substantial cutback in cleanup personnel, the change in audit frequency was warranted.

To maintain consistency in the audit program, and the fact that the TMI-2 cleanup organization has substantially less personnel now that the facility is defueled, the staff finds the change in the Organization Audit frequency appropriate.

The proposed change will not eliminate any vital positions or functions within the TMI-2 organization, nor will it change the personnel qualifications for their positions. The changes are consistent with the current Technical Specifications for TMI-2 and the progress of the cleanup. We, therefore, approve your proposed Organization Plan Revision 23. ORGANIZATION

The organization described in this Plan provides the necessary functional relationships to support the recovery of TMI-2. This Plan provides the organizational structure for management of unit operation and recovery in addition to that organization for unit support in the engineering function.

1.1 GPU NUCLEAR CORPORATION

The GPU Nuclear Corporation organization chart is shown as Figure 1.1. This organization provides engineering and management support for the operation and recovery of TMI-2.

1.2 TMI-2 ORGANIZATION

The TMI-2 Organization chart is shown in Figure 1.2. This organization performs those necessary activities associated with operations, maintenance, and recovery of TMI-2 in addition to engineering, licensing, and safety review and evaluation.

ADMINISTRATION

2.1 PLAN APPROVAL AND AUDITS

- 2.1.1 The docketed TMI-2 Organization Plan and changes thereto shall be approved by the Office of the President, GPU Nuclear Corporation.
- 2.1.2 Changes to the docketed Organization Plan shall be approved by the NRC prior to implementation.
- 2.1.3 The Quality Assurance Department shall conduct audits at a frequency of at least once per 24 months to verify conformance of the organization with the Organization Plan. Either the Safety Review Group (SRG) (until implementation of the IOSRG) or the IOSRG (upon its implementation) shall review the results of such audits and make recommendations as appropriate.

2.2 TECHNICAL SPECIFICATION TITLE CROSS-REFERENCE
